- 1. The committee shall meet minimum four times in a year

Functions of Internal Quality Assurance Cell (IQAC)

- 1. Development of quality benchmarks/parameters for various academic and administrative activities of the institute and apply them to improve quality of education imparted by the institute.
- 2. Facility creation of learner-centric environment conclusive for quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process.
- 3. To collect feedback responses from students, parents and other stakeholders on curriculums offered, teaching, examination and other quality related institutional processes and analyze them to sugget measurements to improve the quality of education imparted to the students.
- 4. To collect self-Appraisal Reports from teaching faculty, anlayze them and suggest measure/ actions to be taken to improve the quality of education.
- 5. Documentation of the various programmers/activities undertaken by the institute for quality improvement.
- 6. Dissemination of information of the various quality parameters of higher education
- 7. Organization of inter and intra institutional workshops, seminars on quality related themes and acting as a nodal agency for coordination of quality related activities, including adoption and dissemination of good practices.
- 8. Development and maintenance of Institutional database for the purpose of maintaining / enhancing the institutional quality.
- 9. Development of Quality Culture in the institute,
- 10. Preparation of Annual Quality Assurance Report (AQAR) of the institute based on the quality parameters/assessment criteria developed by the relevant quality assurance agency like
- 11. Annual development of Quality Radars (QRs) and Ranking of Integral Units of the institute based on AQAR.
